- 2. **AND** it being recorded that the applicant father does not object to or oppose the court's respectful invitation to 'Fathers for Justice'.

# THE COURT RESPECTIVELY INVITES:

The organisation, 'Fathers For Justice' to take all reasonable steps within their power to remove from the internet all information relating to the parties to these proceedings, KATY ASHWORTH, BEN ALCOTT and CHARLIE ALCOTT, specifically, those articles attached and contained in the schedule to this order but not to be limited to the attached list.

# THE COURT ORDERS:

4. There is permission for the mother's solicitor to take the lead in sending an agreed joint letter from the parties to the appropriate person at 'Fathers For Justice' and there is furthermore permission for this order to be attached to that letter.
